

## **ANNEX 2 – TREATMENT OF STATE AID SCHEMES IN THE SPD**

In accordance with Articles 9(m), 18.2(b) and 19.3(b) the Single Programming Document contains a summary description of the measures planned to implement the priorities, including the information needed to check compliance with aid schemes pursuant to Article 87 of the Treaty.

In order to fulfil the requirements of the above regulation, the UK authorities have provided the list of state aid schemes by measure, according to the format requested by the Commission. The list of state aid schemes is attached to this annex. As a general rule, the list referred to above covers all aid schemes already notified and approved by the Commission and which shall be co-financed by the various measures of the programmes.

Besides schemes already notified and approved, state aids granted under the measures will be either compatible with the de minimis rule or it will be applied under an exemption regulation in accordance with Council Regulation No 994/98 of 07.05.1998 (O.J.E.C. L 142 of 14.05.1998).

If a measure is implemented in whole or in part through an aid scheme, which requires approval by the Commission and which has not yet been approved, a suspensive clause on interim payments will be applied at the level of the measure concerned. The suspensive clause will be lifted once the schemes have been notified and approved.

As regards new aid schemes not foreseen in the initial decision approving the SPD, the following provisions shall apply:

- The UK will notify to the Commission (DG Competition) for approval any new aid schemes;
- Once the new aid schemes have been approved, and following the approval by the Programme Monitoring Committee of the insertion of these additional approved aid schemes in the SPD, the UK will submit a revised list of state aid schemes to the Commission (DG Regional Policy);
- In accordance with Art 30 of the General Regulation, the starting date for eligibility of expenditure will be the date on which the UK submits to the Commission the request to modify the assistance by formal Commission decision.

The above provisions deal with state aids schemes co-financed by the European Social Fund and the European Regional Development Fund. As regards EAGGF co-financed state aids, articles 51 and 52 of Council Regulation (EC) 1257/1999, on support for rural development under EAGGF, will apply. As regards FIFG co-financed state aids, provisions under Council Regulation (EC) No 1263/1999 on the FIFG and articles 18 and 19 of Council Regulation 2792/1999 laying down the detailed rules and arrangements regarding Community structural assistance in the fisheries sector will apply.

The introduction of a new aid scheme or ad hoc aid requires a modification of the assistance by a formal Commission decision.

Article 4 of the Commission decision regarding this programme (suspensive clause concerning state aid) applies to measures containing aid schemes that are subject to appropriate measures. At present this applies to measures 1.1, 1.3, 1.5, 1.6, 2.1, 2.2, 2.3, 2.4, 4.1, 4.8, 5.1, 5.2, 5.3.

As concerns these schemes the suspensive clause will be lifted when DG Competition formally signals its agreement to the United Kingdom authorities that the scheme(s) in question fulfill the requirements of the State Aid Rules.
